Cancellation of your PEDICON 2025 registration can be done by writing an email to the conference secretariat - reg.pedicon2025@gmail.com clearly stating your registration number in the subject line. The email is to be sent from the email address which was used for registration.

Please note:

- Cancellation before 30th April 2024 will attract a cancellation fee of 25% of gross registration value (excluding GST)
- All cancellations done between 1st May 2024 to 31st July 2024 will attract a cancellation fee of 50% of gross registration value (excluding GST)
- All cancellations done between 1st August 2024 to 30th November 2024 will attract a cancellation fee of 75% of gross registration value (excluding GST)
- All cancellations done post 1st December 2024 will be non-refundable.
- All refunds will be processed within 6 weeks of the completion of the conference.
- · Timestamp of email will be considered as official date of cancellation request.
- · GST value is non-refundable for any type of cancellation.

TERMS & CONDITIONS
